Properties / Applications

Desmodur[®] E 40480 MPA can be combined with latent hardeners (Bisoxazolidin) to formulate moisture-curing coating and sealing systems for large surfaces. The formulations are characterized by their very good storage stability and dry in thick coats to yield blister-free films.

The films yielded by coatings based on Desmodur[®] E 40480 MPA are flexible, also at low temperatures.

Storage

- Storage in original sealed Covestro container.
- Recommended storage temperature: 10 30 °C.
- Protect from moisture, heat and foreign material.

General information: The product is sensitive to moisture and should therefore be stored in its sealed original containers. Storage at higher temperatures may result in an increase in viscosity. Storage at lower temperatures may cause the formation of crystalline deposits.

Storage time
